#### I. Full Application Questions:

# Q1. IF PRIME RECIPIENTS IS AWARDED A CONTRACT UNDER THE EXPLORATORY FOA, WOULD THEY BE REQUIRED TO ATTEND THE ARPA-E SUMMIT?

**ANSWER**: Please see the DE-FOA-0002784 Funding Opportunity Announcement Table 1: Exploratory Topics schedule of notifications.

Q2. I WANT TO UNDERSTAND HOW THE FUNDING ARRANGEMENT DIFFERS WHEN IT IS A GRANT. PER THE FAQS, "ARPA-E EXECUTES A FUNDING AGREEMENT DIRECTLY WITH THE FFRDC OR GOGO AND A SINGLE, SEPARATE COOPERATIVE AGREEMENT WITH THE REST OF THE PROJECT TEAM." HOW DOES THIS DIFFER IN A GRANT SITUATION? IS A GRANT ISSUED TO FFRDC AND A SEPARATE GRANT TO REST OF PROJECT TEAM?

**ANSWER**: ARPA-E would still execute a funding agreement directly with the FFRDC/DOE Lab and then a single, separate grant with the project team.

#### Q3. WE ARE A SMALL BUSINESS PLANNING TO PARTICIPATE AS A SUBCONTRACTOR TO A LARGE BUSINESS. DOES OUR SMALL BUSINESS QUALIFY FOR THE "COST SHARE GRACE PERIOD"?

**ANSWER**: Cost share is based off the total project cost of the prime recipient, not subcontractors.

Q6. A PI OF OURS HAS A QUESTION REGARDING BULLET FOUR IN TOPIC C OF EXPLORATORY TOPICS (DE-FOA-0002784). THE BULLET IN THE FOA STATES "IMPROVING MANAGEMENT, CLEAN-UP AND DISPOSAL OF RADIOACTIVE WASTE AND SPENT NUCLEAR FUEL." CAN YOU PLEASE PROVIDE MORE DETAILS?

CAN YOU PLEASE CONFIRM THAT THERE'S AN INTEREST IN MANAGING EXISTING SPENT FUEL? ANSWER: ARPA-E cannot provide more details.

Q7. WOULD A PROJECT TARGETING QUANTUM COMPUTING SOLUTIONS TO MONITORING AND OPTIMIZATION PROBLEMS IN ELECTRIC POWER TRANSMISSION SYSTEMS BE RESPONSIVE TO THIS SOLICITATION? THE GOAL WOULD NOT BE TO DEVELOP NEW QUANTUM COMPUTING ALGORITHMS OR METHODS, BUT RATHER TO INTERFACE AND NUMERICALLY EVALUATE EXISTING QUANTUM COMPUTING PLATFORMS.

Q10. FOR THE DE-FOA-0002784 – TOPIC C CREATE FOA, I WANTED TO CONFIRM YOU ONLY NEED THE TOPIC C: SF-424A (FIXED AMOUNT GRANT). WE WANTED TO VERIFY IT REPLACES THE NEED FOR THE SF-424A / BUDGET WORKBOOK SINCE THE UPLOAD SECTION HAS THE TITLE OF SF-424 / BUDGET WORKBOOK, NOT THE TOPIC C: SF-424A (FIXED AMOUNT GRANT). ALSO, LIKE THE OTHER FORM, DO YOU NEED EACH PARTNER TO COMPLETE THE TOPIC C: TECHNICAL VOLUME (COST- REIMBURSABLE GRANT) FORM?

**ANSWER**: Yes, only SF-424A (Fixed Amount Grant) needs to be completed. Yes, each partner needs to complete the Technical Volume Form.

# Q11. FOR THE GRANT SITUATION, IS COST SHARE HANDLED ANY DIFFERENTLY THAN AS IT IS WITH THE COOPERATIVE AGREEMENT?

ANSWER: No.

QUESTION 2: IS A SUBMISSION PERTAINING TO TESTING NOVEL NANOPARTICLES FOR CLEAN-UP OF TANK WASTE (DFLAW) DEFINED AS A PRIORITY UNDER 2022-2032 HANFORD STRATEGIC VISION APPLICABLE TO THIS CALL.

**ANSWER**: ARPA-E will not pre-assess project teams.

Q15. FOR A TYPICAL LARGE BUSINESS, HOW IS COST SHARE ACCOUNTED FOR OVER TIME IN A GRANT SITUATION? IS THE GRANT AMOUNT UPFRONT PROVIDED WITH THE COST SHARE AMOUNT REMOVED OFF THE TOP? OR IS THE FULL AMOUNT THAT BUSINESS PROPOSED, FEDERAL SHARE + COST SHARE PROVIDED THROUGH THEIR GRANT, AND THEN THEY ACCOUNT FOR IT, PROVIDING IT BACK OVER TIME?

**ANSWER**: The large business is responsible for providing their cost share portion in accordance with the SF-424 and subsequently negotiated award.

Q16. WITH THE REQUIREMENT TO SUBMIT A SINGLE "TOPIC\_C\_SF-424A\_(COST\_REIMBURSABLE\_GRANT).XLS" TO REPRESENT THE PROJECT AS A WHOLE, CAN THE LEAD ENTITY JUST PRESENT THE SUB-ENTITIES AS PART OF THE SUBCONTRACT LINE ITEM, WITH THE REST OF THE BREAKDOWN OF LABOR AND SUCH JUST BEING THE LEAD ENTITY'S INFO? HOW WOULD THIS WORK WITH AN FFRDC, SINCE THEY ARE FUNDED SEPARATELY FROM THE REMAINDER OF THE PROJECT TEAM? SHOULD THE FFRDC AS THE LEAD SUBMIT A SINGLE DOCUMENT, BUT WITH THE OTHER ENTITIES AS OTHER TABS?

**ANSWER**: The lead entity must follow the instructions and guidance provided with the SF-424A.

Q17. OUR COMPANY, -REDACT-, IS CONSIDERING APPLYING TO ARPA-E CREATE (DE-FOA-0002784). ONE OF THE REASONS WE'RE ATTRACTED TO ARPA-E WAS OUR UNDERSTANDING THAT YOUR TEAM IS WILLING TO REVIEW A CONCEPT PAPER IN ADVANCE OF A COMPANY SUBMITTING A FULL APPLICATION. HOWEVER, WE DIDN'T SEE THAT OPTION FOR THE CREATE PROGRAM.

WE WERE WONDERING IF WE MISSED THE NOTICE ABOUT THE CONCEPT PAPER SUBMISSION. WE ALSO UNDERSTAND THAT TODAY IS THE FINAL WINDOW FOR ASKING QUESTIONS, SO IN CASE WE CAN'T FOLLOW UP WITH MORE INFORMATION, WE ATTACHED A DOCUMENT TO PROVIDE MORE CONTEXT ON OUR CONCEPT.

GIVEN WHAT WE'RE BUILDING, WOULD YOU ENCOURAGE US TO APPLY TO THE FULL APPLICATION?
